

## **COOKIES POLICY**

This Policy applies to users of one or more K2 INGENIERÍA websites (e.g. www.applusk2.com), including the mobile versions of the Websites owned and operated by **K2 INGENIERÍA**.

In addition, this Policy contains information about *cookies* and other tracking technologies used in the context of the Websites, mobile applications and online services that we offer to you (the "*Cookies*"). "**Online Services**" means the Websites, mobile applications and all information and services provided to you in connection with your use of the Websites, including newsletters, mobile applications, referral tools, sponsored content, advertising, email communication, SMS, online training.

In addition, through the use of *cookies*, personal data is collected and processed. In this regard, we

#### What are cookies?

We use the term "*cookies*" to refer to all technologies that store, and access, information on the device you use to access the Online Services, such as your computer, *tablet* or *smartphone*. For example, we use http *cookies*, which are small text files (usually made up of numbers and letters) that are downloaded when you access our Online Services and allow us to recognize your device.

We use Cookies to improve our users' online experience, as well as to better understand how the Online Services are used. Cookies may tell us if you have visited the Online Services before, or if you are a new user.

## What types of *cookies* are there?

Please review this section which provides an overview of the typology of *cookies* that can be used in an *online environment*.

Depending on the owner of the *cookie*, they can be classified into:

- (a) *First-party cookies*: These are those that are sent to the user's computer or device from a computer or domain managed by the publisher itself, and from which the website requested by the user is provided.
- (b) Third-party cookies: These are those that are sent to the user's computer or device from a computer or domain that is not managed by the publisher, but by another entity that processes the data obtained through cookies.

Depending on the duration of the *cookie*, they can be classified into:

(a) **Session cookies:** These are a type of *cookies* designed to collect and store data while the user accesses a website.



(b) **Persistent cookies:** These are a type *of cookies* in which the data is still stored on the computer or device and can be accessed and processed for a period of time defined by the person responsible for the *cookie*, a time that can vary from a few minutes to several years.

Depending on the purpose of the *cookie*, they can be classified into:

- (a) Analysis cookies : These are those that, processed either by the publisher itself or by third parties, allow the number of users to be quantified and thus carry out the measurement and statistical analysis of the use made by users of the website. To this end, your browsing on this website is analysed in order to improve the offer of products or services.
- (b) **Advertising cookies:** These are those that allow the management, in the most efficient way possible, of the advertising spaces that, where appropriate, the publisher has included on a website, application or platform from which the requested website is provided, based on criteria such as the content edited or the frequency in which the ads are displayed.
- (c) **Behavioural advertising cookies :** These are those that allow the management, in the most efficient way possible, of the advertising spaces that, where appropriate, the publisher has included in a website, application or platform from which the requested website is provided. In particular, these *cookies* store information on user behaviour, obtained through the continuous observation of their browsing habits, which allows the development of a specific profile to display advertising based on it. It is also possible that when you visit a website or when you open an email or message where an advertisement or promotion is published, a cookie is installed in the user's browser that serves to later show you advertising related to searches made and to develop a control of the advertisements in relation to, for example, the number of their views. the location in which they appear, the times at which they are displayed, etc.
- (d) Technical cookies: These are those that allow the user to browse through a website, platform or application and use the different options or services that exist therein, such as, for example, controlling traffic, identifying data or the session, accessing sections or content with restricted access, remembering the elements that make up an order, Carry out the process of purchasing an order, make the request for registration or participation in an event, use security elements while browsing, store content for the dissemination of videos or sound, or share content through social networks.
- (e) **Personalization cookies :** These are those that allow the user to access the website, platform or application, with some predefined general characteristics based on a series of criteria on the user's terminal, such as the language, the type of browser through which they access the website, the regional configuration from which they access the website, etc. etc.



## What *cookies* do we use and why do we use them?

The table below shows the different categories of *Cookies* used by the Online Services, as well as the reason we use them.

# How can you exercise your choices regarding the installation/removal of *cookies*?

Please note that disabling *Cookies* from your browser may result in your access to some or all of the functionalities of our Online Services being prevented, without us assuming any liability in this regard.

Explanations on how to configure your web browser are usually available through the "*Help" menu* of the same browser.

You can allow, block or delete *Cookies* installed on your own device by changing your browser settings. For additional information on how to block *Cookies*, you can access the following sections and links of the most popular browsers:

- Mozilla Firefox

Please note that your choice to decline *Cookies* is specific to each browser you are using. Therefore, if you opt out of *Cookies* on one device and want your choice to apply similarly to another device, you will need to enable the same option for that other device.

As an additional step, with respect to third-party Cookies for the purpose of providing you with interestbased advertising, please note that certain third parties may be members of one of the following selfregulatory online behavioral advertising programs, with appropriate opt-out options:
